1. Duties of the following PT Officers include instructions and reporting requirements as specified herein and other applicable directives.

a. CCDB

- (1) Make all checks for member transmittals, fines, donations, National Home Special Projects and others except where specifically instructed otherwise payable to Grand of the Pacific and mailed to Grand QM, Frank Hilliard, at PSC 517, Box RS-LU, FPO AP 96517-1000.**
- (2) For Life Membership applications in the Paddy Daddy, a check for \$25.00 payable to PT #2 for each applicant will be mailed to CCDB, PT #2. All Life Memberships in the Paddy Daddy will be credited toward National Home Special Projects of the PT of the applicant.**
- (3) PT donations to the National Home Special Projects fund will be made payable to Grand of the Pacific marked for NHSP and mailed to the Grand QM.**
- (4) PT quarterly audits completed by the PT Tightwads are to be emailed to the Grand QM for Quarters ending 30 June, 30 September, 31 December and 31 March Audit reports are due by the end of the month following the end of the quarter audited. PT will retain the original signed copy of the audits.**

- (1) PTChairman will email monthly reports of Hospital visits on forms provided to the Grand Hospital Chairman at grdhost@vfwdeptpacific.org no later than the 27th of each month and the report will include all visits from the 26th of the previous month through the 25th of the current month.**

d. AWARDS

- (1) It is the responsibility of each Seam Squirrel to submit recommendations for special Grand awards to be presented at the 2010 Grand Scratch. The recommendations will be submitted to the Grand Awards Chairman at grdjvc@vfwdeptpacific.org on forms provided and within the time limit announced by the Grand Awards Chairman.**
